SUMMARY OF CHANGES

- NASA is extending the 2020 SBIR/STTR Phase I proposals submission deadline from 5:00 pm Eastern Time (ET), Friday, March 20, 2020 to **5:00 pm ET, Monday, March 23, 2020**;
- As a result of many universities closures, NASA will provisionally accept STTR proposal packages that do not include (1) Research Agreements and/or (2) Research Institute (RI) budgets and that have not been endorsed by the RI provided that NASA receives all required documentation no later than 5:00 pm ET, Friday, April 3, 2020.
- NASA will provisionally accept SBIR/STTR proposal packages that do not include signed letters of commitment from subcontractors or consultants provided that NASA receives all required documentation no later than 5:00 pm ET, Friday, April 3, 2020.

NASA will provide additional guidance on how Small Business Concerns (SBC) and RIs can provide these documents and endorsements <https://sbir.nasa.gov/content/covid-19-impact-nasa-sbirsttr-program>.

All other requirements remain unchanged.
